

AIRPORT CHARGES PROPOSAL 2024-2026

STATUS

-≪INX

- In accordance with Cabinet Regulation Nr. 540 of 5 July 2011, Riga Airport charges proposal was developed and co-ordinated with Airport Users in mutual consultations;
- Consultation process began on 22 November 2022 and a total of 5 consultation sessions were held;
- Consultations concluded on 27 July 2023 when Airport Users supported the Airport's proposal with majority of votes (from 10 voting carriers, 5 voted «for», 4 «against» and 1 abstained);
- Since Airport's proposal concerns changes to charges that according to Section 28 of law «On Aviation» are determined by Cabinet of Ministers, appropriate amendments are necessary to be made in the cabinet regulations setting the charge amounts at Riga Airport
- Riga Airport has submitted the charges proposal to the Ministry of Transport of the Republic of Latvia to ensure that appropriate amendments are made in the Cabinet Regulations No. 111 and No. 823
- Status Update (as of 11 April 2024):
 - Amendments to Cabinet Regulations No. 111 and No. 823 were approved by Cabinet of Ministers on 9 April 2024
 - New airport charges will come into effect from 12 April 2024 (on the next day after the amendments are published in the official gazette «Latvijas Vēstnesis»)
