### **RIX INCENTIVE SCHEMES\***

To ensure continued growth of passenger traffic and increased connectivity of Riga Airport, following incentive schemes are proposed:

# New Destination Incentive

#### **Applicable to:**

- Passenger Service Charge
- Take-Off / Landing Charge

## Passenger Growth Incentive

### **Applicable to:**

Passenger Service Charge

#### **Status Update (11.04.2024):**

- Amendments to Cabinet Regulations No. 111 were approved by Cabinet of Ministers on 9 April 2024
- Incentive schemes will come into effect on 12 April 2024 (on the next day after the amendments are published in the official gazette «Latvijas Vēstnesis»

#### **Main Conditions & Rules:**

- Only scheduled traffic will qualify for incentive;
- Only scheduled carriers that have not operated scheduled flights on the respective route for at least 2 years prior to start of operations, will
  qualify for the incentive;
- Minimum threshold to qualify for the incentive is set at 3500 departing direct passengers during first 6 months of operation on the new route. Only new services fulfilling minimum threshold criteria will qualify for the incentive scheme;
- Incentive will be applied to for a period of 3 years after the start of operations on the new route (for details, please see next slide);
- New services to destinations above 3000 km are entitled to receive discount from the passenger service charge, additionally new services to destinations above 6000 km from RIX will also receive discount from the take-off / landing charge (for details, please see next slide).

#### Incentive will be applied as follows:

- Carrier will pay for the services in full for the first 6 months from the moment of commencement of flights on the new route;
- After 6 months, Riga Airport will recalculate fees and will refund the incentive amount if the conditions for granting the incentives are satisfied;
- During the subsequent flight period the air carrier will be charged a reduced fee in accordance with the conditions of the incentive scheme for all traffic carried on the new route.

- Only scheduled traffic will qualify for incentive, all airlines operating scheduled traffic at Riga Airport qualify for the incentive;
- Incentive will be granted for a scheduled direct passenger traffic increase above the traffic volume threshold in the reference period as set by Riga Airport (for details, please see next slide);
- Traffic already covered by new destination incentive will be excluded from the calculation of passenger growth incentive.

#### Incentive will be applied as follows:

Main Conditions & Rules:

- Carrier will pay for the services in full for the current year;
- After a full year is concluded, Riga Airport will calculate the respective incentive amounts for each carrier and compensate the carrier accordingly.

2024 Q2-Q4: 100% discount applied for direct passenger growth above 2019 Q2-Q4 traffic;

2025 Q1: 100% discount applied for direct passenger growth above 2019 Q1 traffic;

**2025 Q2-Q4:** progressive discount for direct passenger volume above 2024 levels – 50% discount for first 22 500 passengers, 100% for each additional passenger;

**2026:** progressive discount for direct passenger volume above previous year's level -50% discount for first 30 000 passengers, 100% for each additional passenger.
